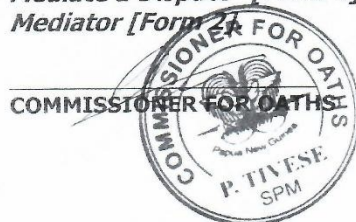

1. I am the First Applicant in this proceeding for and on behalf of the two [2] other Applicants and my Kaplappar clan have full knowledge of this matter and therefore deposed hereto in this Affidavit.
2. The core reasons why and the two [2] other Applicants and myself disputed and taking this matter for mediation is due to the Respondents bringing in the Co-Respondent in to our clan land without our consent.
3. That currently this portion of land "Kalu/Girino" land situated at Kings Village and is on dispute and undergoing mediation under VLC 56/2019.
